Has represented independent inventor/entrepreneur Michael A. Waters and Waters Industries since 1996.

- Obtained patents on valving mechanism for propane tanks that were eventually packaged and sold to a large propane tank manufacturer, Blue Rhino. This lucrative deal hinged on obtaining allowance of patent application directed to commercially significant improvement, which was successfully obtained. Another group of patents directed to patio heaters was also successfully packaged and sold in another multimillion-dollar deal to Uniflame, a well-known consumer heating products manufacturer in Wisconsin.
- Strategically developed Mr. Waters's patent portfolio directed to LED-lighted consumer products (chiefly eyeglasses and hats). The patents have been used to allow the client to carefully cultivate and grow the U.S. and international markets for his products into a business with annual sales of several hundred million dollars, while keeping it free from inferior, lower-cost competitive products. Mr. Waters has also used Fitch Even's litigation group to enforce his patents against these competitive products.

Represents Flexible Steel Lacing Company, a midsized global manufacturer of a diverse range of products for the conveyor belt industry. Have successfully obtained patents for substantially all new product developments over the last 20 years. This company is a market leader in their industry, and the strength of their patent portfolio plays a significant role in maintaining this status.

Represented Tiger Electronics, a Chicago-area toy company later acquired by Hasbro, and wrote and prosecuted several patent applications directed to popular children's toys.

- Obtained patent protection for their most popular toy, the Furby. The Furby incorporated a combination of technological advancements never before used in a hand-held toy, and until the patent issued, it was widely copied due to its immense popularity.

A Chicago-area travel accessories manufacturer wanted new representation for their intellectual property and was referred to Steve by a corporate attorney who worked with another Fitch Even client and had observed our ability to obtain strong, commercially significant patent protection for that client. - Significant holdback running in the form of a multimillion-dollar escrow was proposed by buyer in light of patent risks they identified during due diligence. Was successful in developing non-infringement and invalidity positions for the client that provided purchaser confidence in strength of positions so that holdback was deemed unnecessary.

Participated in competition for patent prosecution for leading global communications technology company Motorola. The company had traditionally prepared and prosecuted all patent applications in house, but was turning to an outsourcing model for this work. Each of the many firms vying for the work was judged on quality of the test patent applications they prepared. Wrote and/or supervised preparation of all the test applications, and on the strength of their quality, Fitch Even was one of the firms selected to be an approved supplier for their outside patent application work.

Represents Tim Grover, a well-known basketball trainer who works with elite basketball players including Michael Jordan, Kobe Bryant, and others. Steve has written patent applications for several of Mr. Grover's novel basketball training devices.
